**Eva Kahan**

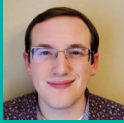
Georgetown University Law Center

**Lauren Owens**

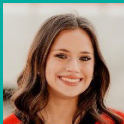

University of Denver's Sturm College of Law

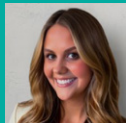

The George Washington University Law School

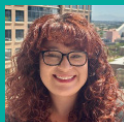

Case Western Reserve University School of Law

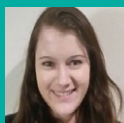

He will be joining that Office as a Fellow and then, hopefully, as a line prosecutor. David says that the JJS Fellowship "aligns with my dedication to serving my community...[w]orking in an office that empowers young lawyers to take on significant courtroom responsibilities and argue meaningful cases is exactly the environment I seek." A 2021 graduate of John Carroll University with a B.A. in Political Science and a minor in History, David's college experience included visiting juvenile correction facilities with the mission of connecting with residents and helping them grow as individuals by teaching them positive and helpful traits that they can utilize upon reentering society.

Hailing from the small town of Fort Morgan in eastern Colorado, Alison has long displayed an interest in law and government service. After earning her B.A. in Journalism from the University of Colorado – Boulder, Alison spent more than four years reporting on government affairs and court proceedings, and then spent a year working at the California Office of the Attorney General and afterwards at AmeriCorps. In law school, Alison served externships and internships at the City Attorney's Office for the City and County of Denver, spent a semester interning for a State Judge, and then two semesters at different sections of the Colorado Department of Law. Alison's Fellowship will allow her to pay bar expenses and support herself while working as a Temporary Aide in the AG's Office while awaiting her bar results. She then will serve as a Department of Law Fellow and seek a position as an Assistant Attorney General. As Alison put it, "I can't wait to get to work! The Justice Jump Start Fellowship [will] allow me to do that- get to work for the people of Colorado- sooner."

Immigrant Justice Corps

Through the Immigrant Justice Corps, Jacob received a two-year placement at the University of Arkansas Immigration Clinic. He will be serving and advocating for unaccompanied children facing removal proceedings, as well as building out a new program within the Clinic. He also will be collaborating with current law students to serve clients directly and create a network of support for unaccompanied children in Northwest Arkansas. A graduate of Trinity College in San Antonio (B.A. in History and Religious Studies) who is starting a second career after a decade in leadership positions, Jacob tells us that, "The Justice Jump Start Fellowship's support bridges the gap between my finishing law school, passing the bar, and moving into the unique opportunity at hand to serve unaccompanied children in the fall. It will enable me to transition from my current job and give my full attention to bar preparations in the short-term, releasing me to focus on my long-term goals of addressing the individual and systemic barriers to safe, accessible resettlement affecting millions of individuals."

Foundation History

The Foundation was established in 2000, endowed with the firm’s awarded lawyers’ fees from the Ironworkers pro bono case. In that case, won by Foundation President John Oberdorfer and others, a federal court in Washington DC struck down racial barriers to union membership faced by African American construction workers building the Washington DC Metrorail system.

2000	Foundation established in honor of Jim Patton at the time of his retirement.
2004	Foundation establishes the Public Policy Fellowship program.
2005	Foundation awards first Public Policy Fellowships to students at the Georgetown University Law Center, The George Washington University Law School, the University of Virginia School of Law and the Southern Methodist University Dedman School of Law. Foundation establishes the Foundation’s Advisory Committee.
2010	First “Issues of Our Time” lecture event. Speakers since have included Ambassador Frank Wisner, international affairs advisor at Squire Patton Boggs; former EU Ambassador to the US David O’Sullivan; and historian/author Lynne Olson.
2012	100th law student participates in the Public Policy Fellowship program.
2013	Public Policy Fellowship grows to 15 law schools. International Fellowship program begins with Qatar law student awarded fellowship.
2015	Foundation adds Fellowships at the law schools at Case Western Reserve and the University of California-San Francisco.
2016	Distinguished Fellows Award created. Qatar Ambassador and Fellows from Qatar honored in Washington. US Ambassador honors 2016 Qatar Fellow in Doha. Foundation hosts symposium on combating poverty.
2017	Expansion of Fellowship program to law schools at the University of Miami and The Ohio State University. 200th law student participates in Fellowship program.
2018	Formation of the Deans’ Circle. Fellowship program welcomes Collège d’Europe and University of Arkansas School of Law.
2019	In conjunction with Deans’ Circle, creation of the Sustained Impact Program, with three Fellows working on post-Hurricane Maria issues in Puerto Rico. Addition of Law-Journalism Fellowship with the Pulitzer Center on Crisis Reporting.
2020	Addition of Georgia State University College of Law and University of Cincinnati College of Law to the Fellowship Program and Deans’ Circle. All 27 Fellows successfully complete remote internships during Covid pandemic. “Issues of Our Time” discussion by Fellows on racial justice.
2021	First Racial Justice Sustained Impact Fellowship Program; letter from Foundation Chair and President to all Fellows on protecting the Rule of Law and advancing toward a “more perfect Union” in response to January 6; special forum among Fellows on same topic; “Issues of Our Time” program honoring Veterans.
2022	Establishment of Veterans’ Justice Fellowship as sixth Sustained Impact Fellowship. First Fellow from Warsaw campus of the College d’Europe.
2023	Creation of Joe Brand Human Rights Fellowship, addition of Human Rights Watch Fellowship and first Fellowships at Sandra Day O’Connor College of Law at Arizona State University, and Loyola Law School (Los Angeles). Record class of 30 brings total number of Fellows to 356.
2024	Creation of the Justice Jump Start Fellowships, expanding its Fellowship program to include three graduating law students and advancing the Foundation’s mission of improving access to justice and the Rule of Law.

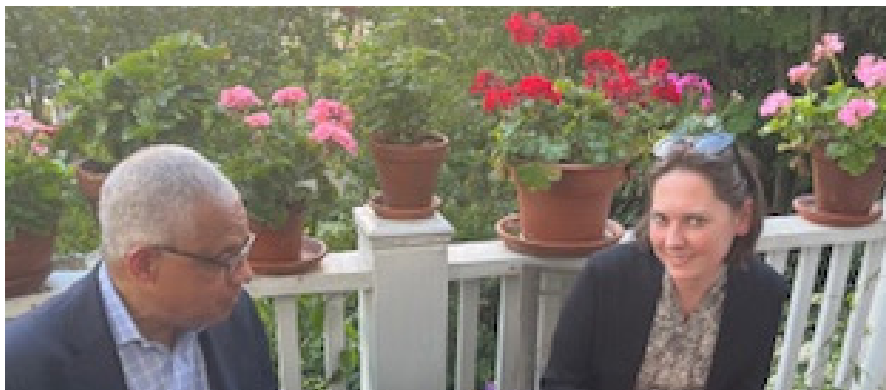

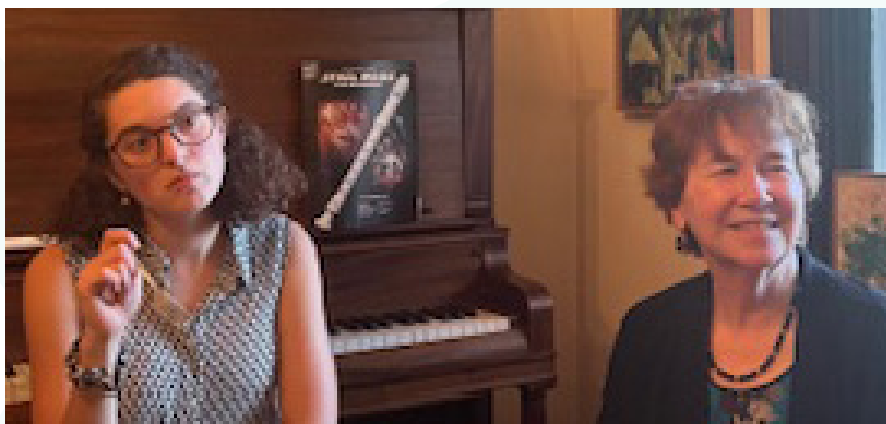

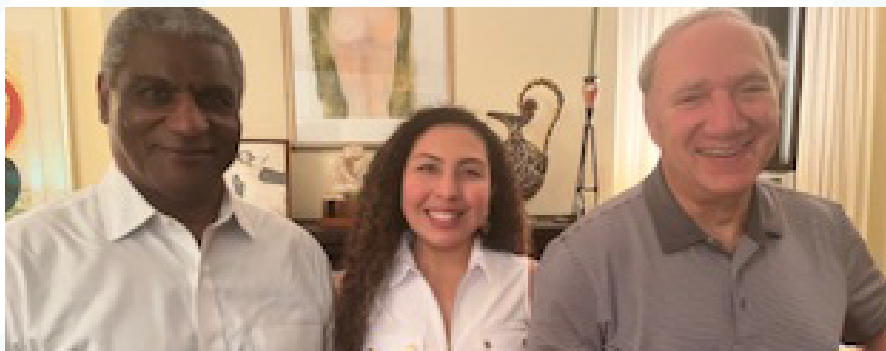
